#### IV. OBSERVATIONS

- In all the Schools visited, 75-80% of Computers and Peripherals were found in working conditions. As the visit was made at the end of the academic year, it was informed that the remaining computers shall be repaired during the vacation period.
- The make of the Computers is either E-SYS or ADCOM.
- The coverage of Internet facilities in the schools is limited. It is informed that the Department of HRD is in consultation with the BSNL and other private players to get Internet connection to all the schools covered under the Project.

- The schools are not maintaining proper stock register of the items received IV. through the Project.
- The vendor of the Project has to open its offices at the District level also, so that they can deliver prompt services as and when required. It has been reported that V. the vendor takes considerable time to attend to the hardware problems, which needs to be sorted out, so that the students can get maximum benefits from the programme.
- In most of the schools visited, the earthing was not done properly. Earth to neutral voltage in most of the cases is found fluctuating. This is turn is affecting vi. the performance of the computers.
- Some of the schools do not have the Operating System CDS which is essential for the repair of minor break down of the Computers due to OS corruption. vii.
- The Department of HRD, GoS, needs to develop some internal mechanism to manage and monitor the Project effectively. A frequent visit to the schools to vill. monitor the Project is felt necessary.

## DEVIATION FROM THE AGREEMENT IN RESPECT OF SUPPLY OF HARDWARE AND V. SOFTWARE

Certain deviations were observed in the supply of hardware and software to the schools by the vendor of the project. The deviations are as follows:

- The processor of the computers supplied is P-IV in lieu of Dual core i. Processor.
- The hard disk is of lower capacity. il.
- Dot matrix printer supplied is of 9 pin in lieu of 24 Pin. iii.
- Limited Internet connectivity to the Schools. iv.
- Software Paper licenses of Windows XP/Vista and MS office not yet submitted to the Department and
- UPS supplied had only one SMF Battery in Lieu of two SMF batteries. vi.

#### ACTIONS TAKEN BY THE DEPARTMENT VI.

After the detailed scrutiny of the reports and files, it is known that the Department of HRD has penalized the vendor an amount of 84, 54,200/- (Rupees Eighty Four Lakhs Fifty Four Thousands and Two Hundred) only, for the discrepancies observed in the implementation of the Project. The said amount shall be deducted from the total project
